Exhibitor policy	 It is not allowed to sell anything other than the goods on display during the festival. However, orders may be taken for other goods. All items sold from the stand must be properly sealed and/or packaged. It is a condition of license for sale at the festival that it is NOT marketed as a "leftovers sale" or suchlike. No merchandise may be sold from the stand. We reserve the right to contact SKAT (the Danish tax authorities) if we observe behaviour that is not in accordance with the applicable rules of sale at the trade show. Forum Copenhagen has exclusive rights to sell food for consumption in the exhibition area. Major activities on the stand must be approved in advance by the sales team. The distribution of advertising material outside the stand area is not permitted. It is not allowed to exhibit outside the rented area, and stand construction, exhibits and advertisements must not block the view of other stands.
The Danish deposit system	One-way packaging which is sold or handed out in Denmark must have a label with a Danish deposit mark to facilitate both the payment and refund of the applicable deposit. The deposit mark not only enables the correct deposit amount to be calculated throughout the distribution chain, but also ensures the return of the maximum amount of one-way packaging, thereby benefiting the environment. Please notice that deposit marks are not needed for beer sold from kegs connected to external tapping equipment.
